It shall be unlawful for any person who peddles, sells, solicits, takes orders for or offers to take orders for any services, wares, merchandise, or goods, including magazines or photographs, from door to door within the city before the hour of Nine A.M. (9:00a.m.) and after the hour of Eight P.M. (8:00p.m.).
Section 12.65 Fee Itinerant Vendor, Peddlers & Solicitors License Fee: \$50 (for sixth month period) **\$25.00 (for one month)**. Each person on application: \$10.00 (for six month period) **(for one month period)**
Section 12.73 A. It shall be unlawful for any person who peddles, sells, solicits, takes orders for or offers to take orders for any services, wares, merchandise, or goods, including magazines or photographs, from door to door within the

city before the hour of Nine A.M. (9:00a.m.) and after the hour of Eight P.M. (8:00p.m.).
